Prices quoted must remain valid for hundred and twenty (120) days from the opening date. The bid security must be valid for one hundred and twenty (120) days from the opening date. **MANUAL SUBMISSIONS WILL NOT BE ACCEPTED.** All tenders must be submitted through the IFMIS PORTAL.

- (v) Pre-bid site visit certificate
- (vi) CR 12 attached should be certified by commissioner of Oath and not more than three months old IDs of Directors to be certified.
- (vii) Attach fully filled, signed and stamped confidential business questionnaire.
- (viii) Attach fully filled, signed and stamped Form of bid
- (ix) All attached pages to be paginated sequentially
- (x) Valid Registration as Special Group Certification A.G.P.O (Where applicable)
- (xi) Copy of valid annual practicing license with NCA in classes specified above.
